### **Nomination Criteria**

Nominee must be **a licensed and practicing Realtor or affiliate** in San Luis Obispo County and must demonstrate excellence in all of the following three categories:

1. **Leadership.** The nominee must demonstrate that his/her long-term dedication and commitment has had a positive, sustaining influence within a community, business, organization, or cause. The nominee is a role model, community leader, mentor, or has broken new ground, and he/she is an agent for change who has made a measurable difference to those around him/her.
2. **Business.** The nominee must demonstrate excellence in innovation, creativity and entrepreneurship in real estate or related industries. The nominee must show a history of active involvement in the community and business associations and have proven outstanding business growth and innovation within his/her business.
3. **Service.** The nominee must demonstrate outstanding contributions over a period to his/her community or to a non-profit or charitable cause. The nominee lives in such a way to serve others, through career and volunteer activities and takes risks to pursue activities that he/she believes in.
