



REALTORS! HERE IS ANOTHER BENEFIT OF JOINING OR RENEWING YOUR MEMBERSHIP IN THE WOMEN'S COUNCIL OF REALTORS® BONITA SPRINGS-ESTERO NETWORK!

Members of the Women's Council of Realtors® who hold their primary membership in the Bonita Springs-Estero Network may be eligible for scholarship reimbursement for specific *higher education courses*

*REALTOR® members may submit a Scholarship Application for the following courses only:*

- *PMN courses*
- *Courses from the NAR Family Designations and Certifications (information available at [nar.realtor/education/designations-and-certifications](http://nar.realtor/education/designations-and-certifications))*
- *National Affiliates may only submit a Scholarship Application for career-specific licensing or accreditation courses in furtherance of their current professional designation.*

To be eligible for scholarship reimbursement, a REALTOR® member or National Affiliate must meet the following criteria:

- Must be a Women's Council of Realtors® member in good standing for at least one (1) year.
- Must hold his/her primary membership in the Bonita Springs-Estero Network.
- Must submit a *scholarship application package* to the Treasurer no later than the deadline specified on the Scholarship Application form. The *scholarship application package* must contain three (3) items: (1) a completed and signed Scholarship Application form, (2) a copy of the paid receipt, and (3) a copy of the Certificate of Completion.

Requests for scholarship reimbursement are subject to the following limits:

- For REALTOR® members or National Affiliates who served on at least one (1) committee or on the Governing Board during the year for which scholarship reimbursement is requested, the dollar (\$) amount of scholarship eligible for request is the LESSER OF:

1. the actual out-of-pocket cost of the course(s), as demonstrated by the paid receipt(s), OR
2. two (2) times the member's annual Network membership fee for the year in which scholarship reimbursement is requested.

- For REALTOR® members or National Affiliates who DID NOT serve on a committee or on the Governing Board during the year for which scholarship reimbursement is requested, the dollar (\$) amount of scholarship eligible for request is the LESSER OF:

1. the actual out-of-pocket cost of the course(s), as demonstrated by the paid receipt(s), OR
2. one (1) times the member's annual Network membership fee for the year in which scholarship reimbursement is requested.

Reimbursements will be distributed on a pro rata basis, depending on the amount budgeted for the year and the number of members who request reimbursement.
