Women's Council of REALTORS® Englewood on the Gulf

Award Project Team

The Awards Project team consists of 1 (one) Past President, President, 1 REALTOR and 2 (two) members at large.

- The Project Team is looking for nominations to be placed in the Network Newsletter and/or email blasts to the membership 60 days prior to the ceremony.
- Members will be allowed to nominate any other member including a governing board member or strategic partner.
- The Project Team will review all nominees and present the list to the governing board to be voted on.
- A member may receive only 1 award each year.
- A member shall not receive more than 2 awards within 3 years.

Requirements:

- Must be a member in good standing.
- Must have been a member of the Local Network for a min. of 2 (two) years.
- Must be actively serving on 1 (one) or more Project Teams during the year they are nominated.

REALTOR® of the Year

This award is presented to a member that has shown outstanding support for the Women's Council of REALTORS® and is a top-level REALTOR®.

Member of the Year

This award is presented to a member who has shown outstanding support for Women's Council of REALTORS® by example or by their response when guidance & knowledge is requested, extends a positive influence, and reinforces the efforts put forth by the leadership of Women's Council of REALTORS®. The recipient should not serve on the Governing Board.

Partner of the Year

This award is presented to a National Affiliates/Strategic Partner who has exemplified the objective of Women's Council of REALTORS® by example or by their response when guidance & knowledge is requested, extends a positive influence, and reinforces the efforts put forth by the leadership of Women's Council of REALTORS®.

Humanitarian of the Year

This award is presented to a member who has given time and talent to one or more organizations, who has volunteered many hours of service on a continuous basis, and by way of example, is a role model for other Women's Council of REALTORS® members. The Humanitarian of the Year will be asked to complete the State application, to be submitted to the State by the Chair (if qualifications are met).

• The nominee should have freely volunteered their time and talents to one or more organizations. That person should have volunteered many hours of service and commitment on a continuous basis and provided "hands-on" involvement to a specific cause. This member, by way of example, is a role model for other Women's Council of REALTOR® members.

Mentor of the Year

This award is presented to a member to give recognition, publicity, and regard for their efforts, time and talent expended in the interest of their fellow members, their profession, and the community.

Rising Star

This award is presented to a member who has participated on more than one project team, has demonstrated leadership skills, and has a desire to learn more and to participate on higher levels. The nominee has assumed tasks and went beyond what was asked and demonstrated the ability to be creative and motivated. The recipient should not serve on the Governing Board.

Lifetime Achievement

This award is presented to a REALTORS® member who has exemplified the true spirit in supporting Women's Council of REALTORS® over many years.

Entrepreneur of the Year

The applicant must qualify based on the State requirements. Must be a member of the Women's Council of Realtors® for a minimum of 1 (one) year.

- Must have accomplished outstanding business results within the last year.
- Must have attended a min. of 2 (two) industry events within the last year.
- Must have achieved a new Designation within the last year.
- Must have served on 1 (one) or more committees with the Local Association or State Association
- Mentored other women in the profession.

President's Award

The President might present a special award of her/his choice to any member of the local network.
